4. That they will keep 24-7 DVD fully indemnified against all losses and all actions claims proceedings costs and damages and all legal costs or other expenses arising out of any breach of any of the above warranties or out of any claim by a third party based on any facts which if substantiated would constitute such a breach.
5. In the event of third party intervention the Customer agrees to provide 24-7 DVD with all relevant information, papers and documents that 24-7 DVD shall reasonably require to enable them to investigate the problem.
6. In the event of 24-7 DVD being prevented from completing their contract by third party action or if 24-7 DVD have reasonable grounds for believing that the Customer's copyright or other relevant rights are open to question then 24-7 DVD may cease production immediately. In that event the Customer agrees to pay all production costs incurred to the date of cessation, and will make no claim against 24-7 DVD for breach of contract or otherwise.
